ORDER

An amount of Rs 3,00,000 (Rupees Three lakhs) only sanctioned vide G.O. No. 160-P (Sanc.) Dt. 12-07-2011 of the Nodal Officer & Joint Secretary to the Govt. of West Bengal, Home (Pol) Deptt., out of which an amount of Rs. 2,98,500 (Rupees Two lakhs ninety eight thousand five hundred) of Column No. 6 is hereby sub-allotted to the Executing Agency mentioned in Column No. 3 for implementation of the scheme mentioned in Column No. 2 after deduction of contingency @ 0.5% for District Head Quarter in Column No. 5 under Border Area Development Programme (B.A.D.P.) of Nadia District as noted below :-


The Charge is debitablc to the Head "2575 Other Special Areas Programme - 60-Others -800-Other Expenditure -SP-State Plan (Annual Plan and Eleventh Plan)-009-Public Health Engineering Sector(i) Creation of source of potable water (BAPD)[PL]-27 - Minor Works / Maintenance - V" under Demand No.27 in the current year's overall On Account Budget.

The Executing Agency should prepare Plan & Estimate and get it vetted by the competent authority. The work should be completed within **3 (three)** months. Monthly Progress report should be submitted regularly. Photograph and Utilisation Certificate should be submitted on completion of the scheme.

A signboard must be installed permanently and prominently at the work site of the scheme.

The scheme should be implemented after the due observance of Govt. Rules and Order.
