An amount of Rs 32,50,000 (Rupees Thiry two lakhs fifty thousand ) only sanctioned vide G.O. No. 154-P (Sanc.) Dt. 12-07-2011 of the Nodal Officer & Joint Secretary to the Govt. of West Bengal, Home (Pol) Deptt., out of which an amount of Rs. 28,35,750 (Rupees Twenty eight lakhs thirty five thousand seven hundred fifty ) of Column No. 6 is hereby sub-allotted to the Executing Agencies mentioned in Column No. 3 for implementation of the schemes mentioned in Column No. 2 and contingency @ 0.5% for District Head Quarter in Column No. 5 and Balance stood Rs.4,00,000 (Rupees Four Lakh) only under Border Area Development Programme (B.A.D.P.) of Nadia District as noted below :-

The Charge is debitable to the Head 2575-Other Special Areas Programme-60-Others-800-Other Expenditure-SP-State Plan (Annual Plan and Eleventh Plan) - 014 - Education Sector -Renovation /Construction / Expansion of School [PL] 21-Materials & Supplies / Stores & Equipments-04-Others-V" under Demand No. 27 in the current year's overall On Account Budget.


The Executing Agencies should prepare Plan & Estimate and get it vetted by the competent authority. The works should be completed within **3 ( three) months**. Monthly Progress report should be submitted regularly. Photograph and Utilisation Certificate should be submitted on completion of the schemes.

A signboard must be installed permanently and prominently at the work site of the scheme.

The scheme should be implemented after the due observance of Govt. Rules and Order.
