All Expenditure Monitoring Officers / Treasury Officer for respective Sub-Divisions has kindly been designated by District Magistrate & District Election Officer, Nadia to receive & making necessary scrutiny of said accounts.

As such, you are requested to inform all Contesting Candidates under your jurisdiction immediately to submit their Accounts of Election Expenses before Officer-in-Charge, Expenditure Monitoring Cell at Sub-Divisional level 2011 without fail.

In case of Sadar Sub-Division, OC- District Election Section, Nadia Collectorate will receive such Accounts of Election Expenses. Treasury Officer, Treasury No.-I, Krishnagar, Nadia and Addl. Try. Officer, Try. No.-I (Pension), Nadia are requested to make necessary scrutiny of the same under supervision of OC-District Election Section, Nadia.
