

11-3-2011	<p>Whereas announcement for ensuing Assembly General Election, 2011 has been issued by Election Commission of India vide No. ECI/PN/17/2011 dated 01-03-2011.</p> <p style="text-align: center;">And</p> <p>Whereas ECI in its letter no. 464/L.&amp;O/2007/PLN-1 dated 08-01-2007 has advised to undertake several prophylactic measures after the announcement of election to ensure conduct of peaceful, free and fair poll and maintenance of law and order situation during general election.</p> <p style="text-align: center;">And</p> <p>Whereas during the period of campaigning, gathering of a large number of people at different places may take place for meeting.</p> <p style="text-align: center;">And</p> <p>Whereas political parties may organise procession at different places.</p> <p style="text-align: center;">And</p> <p>Whereas if any person carries or displays arms during such gathering, then it may lead to a big law and order problem.</p> <p style="text-align: center;">And</p> <p>Whereas any person/persons display/displays or carry arms even in other public places, it may create an atmosphere which will not be conducive for peaceful conduct of election.</p> <p style="text-align: center;">And</p> <p>Whereas I am satisfied that it is a situation for urgent measures to be called for and there is sufficient ground for drawing up proceeding u/s 144 Cr.PC. to adopt preventive Law and Order actions for ensuring peace and tranquillity &amp; for conducting peaceful, free &amp; fair election to the ensuing Assembly General Election, 2011.</p> <p>I, Rashmi Kamal, I.A.S., Additional District Magistrate (General), Nadia, in exercise of the Power conferred upon me under Section 144 Cr.PC. do hereby promulgate this order throughout the District of Nadia banning the carrying and display of any type of licensed arms as defined in Arms Act, 1959, from 14-03-2011 to 13-05-2011.</p> <p>Let the copy of this order be served upon the concerned Officials for execution and for wide publicity.</p> <p style="text-align: right;">             14/3/11            Additional District Magistrate (JM)            Nadia         </p>
