NOTIFICATION

No. 1368-ES/S/10M-134/11- dated the 16th November, 2011. — Whereas it has been reported to the Government that about 35 minor students of a South Kolkata School were waylaid on their way to the school and induced to join a rally organized by a political party without knowledge or consent of their guardians or the school authorities on the pretext of showing them places of tourist attraction in the city;

And Whereas it has also been reported to the Government that repeated incidents of violence and indiscipline in educational institutions are fuelled largely by petty political considerations and idiosyncrasies;

And Whereas the State Government has considered it necessary to ensure that the entire system of school education need to be free of political influence to address spontaneous public outcry against use of educational institutions and minor school children for political purposes;

Now, Therefore, in exercise of the power conferred by sub-section (2) of section 35 of the Right of Children to Free and Compulsory Education Act, 2009 (No. 35 of 2009) read with section 107 of the West Bengal Board of Primary Education Act, 1973 (West Bengal Act XLIII of 1973) and
