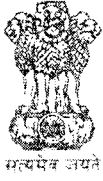

CIRCULAR

This is to inform all concerned that some people are misleading people especially parents of children with disabilities regarding financial facilities to be extended to them on monthly basis regularly from the end of an office located at Bikash Bhavan, 2nd Floor, Saltlake, Kolkata-91 through the office of BDOs. As learned from few such victimized parents, the person concerned (sometimes disabled) is visiting the homes of families having disabled persons/ children, mobilizing them and asking for some money to facilitate the matter and where ever the parents are not convinced suggesting the family members to swear affidavits and submit the same to that unknown office located at 2nd floor of Bikash Bhavan. As the SPO, PBSSM is located in 2nd floor of Bikash Bhavan and there is a cell for facilitation education for children with special needs, people are coming to this office and getting frustrated.

In this connection, this is to state that no such process is being followed from this office to extend the IE interventional benefits to the special needs children (children with disability), rather benefits to the CWSN is routed through the schools where they are enrolled through the office of DPO, SSM/ CLRCs.

All DPOs are hereby informed to inform the matter to all the special educators to transmit the message amongst parents of CWSN and community members so that the families of and persons/children with special needs do not fall prey to this racket.
