NOTICE

As per decision of the Selection Committee for Juvenile Justice Board, Nadia, applications are invited from bonafide persons belonging to the district of Nadia for consideration of recommendation to the State Govt. for the 2(two) posts of social worker members of the Juvenile Justice Board, Nadia consisting of a Judicial Magistrate of the 1<sup>st</sup> class and two social workers of whom at least one shall be woman, forming a bench.

The Board shall have a tenure of three years and the appointment of members shall be co-terminus with the tenure of the Board.

**# Qualification for Members of the Board:-**

1)The Social worker to be appointed as a member of the Board shall be person not less than 35 years of age and not above 65 years of age, who has at least a graduate degree in Social work, health, education, psychology, child development or any other discipline and has been actively involved and engaged in planning, implementing and administering measures relating to child welfare for at least seven years. The age will be reckoned as on 01.6.2011.

2)No person shall be considered for selection as a Member of the Board, if he-

- a)has been convicted under any law;
- b)have ever indulged in child abuse or employment of child labour or any other human rights violations or immoral act;
- c)is holding such other occupation that does not allow him to give necessary time and attention to the work of the Board;
- d) does not fulfill the qualification and experience prescribed in the Juvenile Justice (Care and Protection of Children) Act and the Rules made there under and in such a case the Selection Committee shall after due inquiry and on establishment of such fact, reject his application and recommend the name of the next person from the list of names prepared for filling the vacancies.

**# Sitting and conveyance allowances:-**

The Social Worker members of the Board shall be paid such travel and sitting allowances as the State Govt. may determine.

# The Selection Committee shall select and recommend a panel of names to the State Govt. for the appointment of the members of the Board.

#While appointing the Social Workers of the Board, the State Govt. may, at the time of considering the names recommended by the Selection Committee, also take into consideration, any other person belonging to the concerned district, who is, in its opinion, suitable to be appointed as social worker.
