The Sabhadhipati, Nadia Zilla Parishad and Chairman, District Level Vigilance & Monitoring Committee, Nadia took the chair.

He initiated the discussion by placing the up-to-date reports and the Action Taken Reports on the points in the last meeting and invited all the members present to take part in the discussion specific to the points pertaining to this committee.

The District Magistrate, Nadia elaborated on the points raised in the resolutions adopted in the meeting of D.L.V. & M.C held on 17.08.2010.

The District Magistrate, Nadia informed that Govt. has introduced the new website in connection with District Level Vigilance & Monitoring Committee wherein the complaints can be up-loaded for necessary follow-up. In replying to a question raised in the meeting he stressed the need of mandatory 'display of beneficiary-list' in respect of all the schemes. He also opined that accounts should be operated on biometric decision and then there would be no possibility of one's money going into another's account.

The District Panchayat & Rural Development Officer, Nadia reported that the lists of beneficiaries in connection with NSAP (i.e. I.G.N.O.P.S., I.G.N.W.P.S. & I.G.N.D.P.S.) and PRCTALAL etc. are available in the web-site, but many Gram Panchayats are not displaying the up-to-date list in the office.

Regarding the situation of the Narayanpur-II G.P. under Karimpur-II Block Sri Prafulla Kumar Bhowmik, Hon'ble M.L.A. desired to have the up-to-date status. The District Magistrate, Nadia stated that a status report would be obtained from the Sub-Divisional Officer, Tehatta.

Hon'ble M.L.A. Sri Ashok Banerjee submitted complaints to the Sabhadhipati for information and taking necessary action.

The District Magistrate, Nadia desired to write D.O. letters to all the Sub-Divisional Officers and Block Development Officers urging them to send specific Action Taken Reports without reference to the higher authorities since they are the competent authorities to take actions.

The District Magistrate, Nadia urged the Additional District Magistrate (Dev), Nadia to take necessary action after re-confirmation on the point regarding the deduction of VAT in Anishmali Gram Panchayat and other Gram Panchayats as broached in the meeting.
