<p>Decision: Seen the order passed by Hon'ble Justice Mr. Aniruddha Bose, J., Calcutta High Court dated 07.07.2011, which is as follows - "The petitioners are existing operators of auto rickshaws in the route between Bhairab Chandrapur and Gopalpur. Their grivance is over issue of fresh permits for contract carriage in respect of auto rickshaw in the same route to new operators in the absence of proper facilities for auto stand .Under the existing provision of law, in a route which is not notified, it is not permissible to prevent issue of permits to rival operators on the complaint of existing operators.</p> <p>Under the Motor Vehicles Rules , however , particularly Rule 182 of West Bengal Motor Vehicle Rules 1989, there is provision for imposing restriction on the number of Auto Rickshaws in a particular stand or over use of a particulars location as auto rickshaw stand.
