NOTICE

As per decision of the Selection Committee for Child Welfare Committee, Nadia, Applications are invited from bonafide persons belonging to the district of Nadia for consideration of recommendation to the State Govt. for reconstitution of the Child Welfare Committee, Nadia, which shall consist of a Chairperson and four other members, of whom at least one shall be a woman. The committee shall have a tenure of three years and the tenure of Chairperson and members shall be co-terminus with the tenure of the committee.

Qualification for Chairperson and members of the CWC:-

- 1) A person to be selected as a Chairperson or Member of the Child Welfare Committee shall have at least a graduate in any of the disciplines, preferably in social science in addition to a minimum of seven years experience in their respective field;
- 2) The Chairperson or a member of the Committee shall be a person not less than 35 years of age and not above 65 years of age as on 01.6.2011.
- 3) No person shall be considered for selection as a Chairperson or Member of the Committee, if he,-
 - a) has a previous conviction record;
 - b) has been involved in any immoral act or in an act of child abuse or employment of child labour;
 - c) is holding such full-time occupation that may not allow him to give necessary time and attention to the work of the Committee as per the Juvenile Justice (Care and Protection of Children) Act 2000 and J.J. (Care and Protection of Children) Rules 2009;
 - d) does not fulfil the qualification and experience prescribed in the Act and the Rules made thereunder, and in such a case the Selection Committee shall after due inquiry and on establishment of such fact, reject his application and recommend the name of the next person from the list of names prepared for filling the vacancies.

Sitting and conveyance allowances:-

The Chairperson and Members of the Child Welfare Committee shall be paid travel and sitting allowances, as the State Govt. may determine.

The Selection Committee shall select and recommend a panel of names to the State Govt. for the appointment of the Chairperson and Members of the Committee.

The Selection Committee or the State Govt., as the case may be, while selecting the Chairperson and Members of the Committee, shall as far as possible ensure that none of them are from any adoption agency.

While appointing the Chairperson or the Members of the Committee, the State Govt. may, at the time of considering the names recommended by the Selection Committee, also take into consideration the names of any other person belonging to the concerned district, who is, in its opinion, suitable to be appointed as the Chairperson or the Member, as the case may be.

Applications addressed to the District Magistrate and the Chairperson of the Selection Committee for Child Welfare Committee, Nadia, to be made in neatly typed plain paper giving full bio- data stating name, address, phone No.,date of birth, educational qualifications, experience, present occupation, other

activities etc.,with a self –declaration of submitting true and correct information and duly signed with date,along with photo and attested copies of the relevant documents and testimonials and contained in a closed envelop superscribed with the name of the post applied for, may be submitted at the Social Welfare Section, Nadia Collectorate, upto 20.6.2011 except holidays.
