
1. Rate should be offered per head per day basis.

3. Supplying of heavy Breakfast and Tea at 8.30 a.m.
4. Supplying of Tea and 2 pieces Biscuits at 11.00 a.m. during training session.
5. Supplying of Lunch at 1.00 p.m. (Veg. & Non-veg).
6. Supplying of heavy tiffin at 6.00 p.m.
7. Supplying of Dinner at 9.00 p.m. (Veg. & Non-veg).
8. Supplying of Chatni, Cards & Sweets (one piece) at Lunch & Dinner every day.
9. In case of vegetarian, sufficient no. of veg. item be supplied at Lunch & Dinner.


