


TENDER NOTICE


1. The rate should be offered for 4 (four) heads per day
2. The dishes should be cleaned every day after lunch and dinner with liquid soap.
3. All utensils should be cleaned every day before starting of cook and thereafter with liquid soap.
4. All the Residential rooms, Training room, Reading room, Kitchen, Dining and the Campus of DTC should be cleaned every day.
5. All the above mentioned rooms should be cleaned with water and Phenyl / Dettol Liquid Soap in every day.
6. All the Toilets, Latrines and Basins Drains etc should be cleaned with Harpic and Muritic Acid / Bleaching Powder in every day.
7. The caretaking of children of trainees (Female) will be borne to the Tenderer.
8. The Bed cover, Pillo cover, Towel of each bed should be washed with soap twice as a week and changing of these items should also be done.
