

Press Note

In connection with Special Summary Revision of Photo Electoral Roll-2016

Date & Time of Press Meet : 25-08-2015 at 4:30 p.m.

Venue : Conference Hall of Administrative Building of Nadia Collectorate.

As per order of the Election Commission of India as well as Chief Electoral Officer, West Bengal, this district is going to organise the Summary Revision Programme for 17 A.Cs like previous years with reference to 01.01.2016. The Election Commission of India has declared this Revision Programme as Special Summary Revision in nature.

The Schedule of Revision-2016 is as follows :

5	Disposal of Claims and Objections	By 09-11-2015 (Monday)
6	Final Publication of Electoral Rolls	05-01-2016 (Tuesday)

- There are 4527 nos. of polling stations where designated officers will remain present from 11:00 a.m. to 4:00 p.m. on working days and 10:00 a.m. to 5:00 p.m. on Special Campaign dates to receive claims and objections during the period from 01-09-2015 to 18-09-2015.
- All eligible persons can apply in the prescribed Form to the Designated Officer available with them.
- **Use of Forms**
 - (1) Form – 6 - for enrolment of new voters and shifted from other ACs
 - (2) Form – 6A - for enrolment of overseas electors
 - (3) Form – 7 - filing any objections for a particular entry in the Electoral Roll.
 - (4) Form – 8 - for any correction of a particular entry in the Electoral Roll.
 - (5) Form – 8A - for transposition of names from one part to another part within the same Assembly Constituencies.

- All the claims and objections received during the period of filing claims and objections i.e. Form 01-09-2015 to 18-09-2015 shall be entered in the ECI's portal for public viewing and can file objections against any applicant.
- The Draft Photo Electoral Roll-2016 shall be handed over to all the Recognized National and State Parties on 01-09-2015 from respective Sub-Divisional Office to the authorised representatives of the party on proper receipt.
- In connection with the Special Summary Revision-2016, Electors' Information Slip shall be distributed to each electors for verification of particulars in the Electoral Roll shall be distributed through concerned Booth Level Officer within 1st week from commencement of Revision Programme-2016 i.e. from 01-09-2015 to 07-09-2015.
- During this Special Summary Revision, all recognised Political Parties can appoint their Booth Level Agent on 1:1 basis (one polling station, one BLA)
- As per instruction of the Commission, Booth Level Agents of any Recognized Political Parties can file applications in bulk not more than 10 Forms at one time in one day but not more than 30 Forms during the entire period of filing claims and objections subject to the condition that BLA should submit written declaration prescribed by the Commission.
- During this Special Summary Revision, the list of claims and objections filed in the 17 ACs shall be handed over to all the Recognized Political Parties for their information on weekly basis calling a meeting with political parties on the following dates:
 - on 11-09-2015
 - on 18-09-2015
 - on 24-09-2015
- As per Draft list of Photo Electoral Roll-2016 to be published on 01-09-2015, the total electors of 17 ACs will be as per enclosed statement.
- All media persons including electronic media are requested to circulate the salient features of the Revision programme -2016 through their electronic media as far as practicable.
